1. MINUTES:

5. COMPULSORY PURCHASE OF FIVE LONG-TERM VACANT PROPERTIES (Report of the Cabinet Member for Resources and Performance and the Cabinet Member for Housing, Planning and Regeneration – Agenda Item 8):

For the reasons set out in the Cabinet Members' report, the Committee RESOLVED –

- (1) That the making of five separate Compulsory Purchase Orders, under Section 17 of the Housing Act 1985 and the Acquisition of Land Act 1981 be authorised in respect of the properties identified as 'a', 'b', 'c', 'd' and 'e' in the exempt report.
- (2) That, subject to the authorisation for the making the Compulsory Purchase Orders referred to in (1) above, the Orders be submitted to the Secretary of State for Communities and Local Government for consideration and confirmation.
- (3) That, in the event of the Secretary of State for Communities and Local Government returning any of the Orders for confirmation by the Council, the Order be confirmed on behalf of the Council.
- (4) Following confirmation of any of the Orders, to authorise the entry into a crossundertaking with the owner(s) of the relevant property not to implement the Order on the condition that the owner(s) agree(s) to bring their property back into use within a reasonable time.
- (5) In the event that a cross-undertaking is not entered into as referred to in (4) above, or the terms of the cross-undertaking are not adhered to by the owner, that the Director of Planning, Housing and Regeneration be authorised to proceed with the compulsory acquisition of the property in question.

- (6) That following the compulsory acquisition of any of the properties, a proposal for the onward disposal to the private sector be referred to the relevant Chief Officer for decision and progression.
- (7) That the financial costs of the Compulsory Purchase Orders be indemnified through the Corporate Capital Programme.
