Granville Road Development

Statutory Notice under Section 5A of the Acquisition of Land Act 1981

Salutation

We act on behalf of the London Borough of Barnet (the "Council").

You may be aware that the Council, as an acquiring authority using compulsory purchase powers for planning and public purposes, is considering making a compulsory purchase order (the "Order") under Sections 226(1)(a) and 226(3)(a) of the Town and Country Planning Act 1990 to acquire land and interests within the Granville Road Estate (the "Land") as part of the Granville Road development scheme ("the Scheme").

TerraQuest is a land referencing company. We have been instructed by the Council to research the land ownership in connection with the Order. The information the Council is collecting is required to ensure that all parties with an interest in the Land can be formally notified of the Order, kept informed throughout the process and their interest recorded for compensation purposes.

We are writing to you now under Section 5A of the Acquisition of Land Act 1981 because we believe you may have an interest in, or over the land, which is within, or is in close proximity to, the proposed Granville Road development.

This is a statutory notice which requires you to provide information about your interest in the Land. It is a legal requirement that you respond within 15 days.
